Report on the Audit of the Financial Statements

Opinion

1. We have audited the accompanying financial statements of **Neonates Critical Care Foundation** ('the Company'), which comprise the Balance Sheet as at 31 March 2024, the Income and Expenditure Account and the Cash Flow Statement for the year then ended, and notes to the financial statements, including a summary of the significant accounting policies and other explanatory information.
2. In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ('the Act') in the manner so required and give a true and fair view, in conformity with the Accounting Standards specified under section 133 of the Act, read with the Companies (Accounting Standards) Rules, 2021 and other accounting principles generally accepted in India, of the state of affairs of the Company as at 31 March 2024, and its excess of expenditure over income and its cash flows for the year ended on that date.

Basis for Opinion

3. We conducted our audit in accordance with the Standards on Auditing specified under section 143(10) of the Act. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ('ICAI') together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act and the rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Information other than the Financial Statements and Auditor's Report thereon

4. The Company's Board of Directors are responsible for the other information. Other information does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

The Directors' Report is not made available to us at the date of this auditor's report. We have nothing to report in this regard.

Responsibilities of Management for the Financial Statements

5. The accompanying financial statements have been approved by the Company's Board of Directors. The Company's Board of Directors are responsible for the matters stated in section 134(5) of the Act with respect to the preparation and presentation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the Accounting Standards specified under section 133 of the Act, read with the Companies (Accounting Standards) Rules, 2021 and other accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.
6. In preparing the financial statements, the Board of Directors is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Statements

7. Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Standards on Auditing will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.
8. As part of an audit in accordance with Standards on Auditing specified under section 143(10) of the Act, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:
 - Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control;

 - Conclude on the appropriateness of Board of Directors' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern; and
 - Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

This report does not include a statement on the matters specified in paragraph 3 of the Companies (Auditor's Report) Order 2020 ('the Order'), issued by the Central Government of India in terms of section 143(11) of the Act, since in our opinion and according to the information and explanations given to us, the Order is not applicable.

As stated in note 19 to the financial statements and based on our examination which included test checks, the Company, in respect of financial year commencing on 1 April 2023, has used an accounting software for maintaining its books of account. In the absence of evidence, we are unable to comment on whether the said accounting software had a feature of recording audit trail (edit logs) facility and if the same was enabled and operated throughout the year.

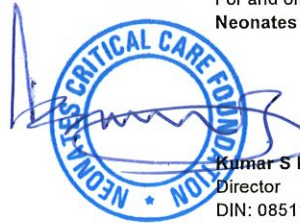

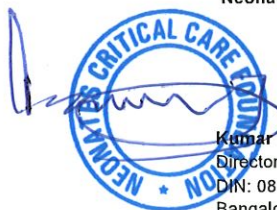

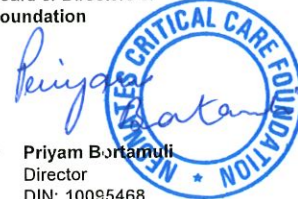

Summary of Significant accounting policies and other explanatory information

(All amounts in ₹'000, unless otherwise stated)

1 Background Information

Neonates Critical Care Foundation (the 'Company'), a Company registered under Section 8 of the Companies Act, 2013 (the 'Act'), was incorporated in Bengaluru on 27 December 2018. The Company is engaged in the business of providing healthcare assistance to underprivileged new born babies requiring neo-natal intensive care, admission and treatment, and to guide, educate and create health awareness program and provide support for neonatal intensive care treatment.

The Company has following registrations under various acts-

a) The Company has been registered under Section 12A of the Income Tax Act, 1961 with effect from 10 September 2020 and its registration number is CIT(EXEMPTIONS)BANGALORE/12AA/2020-21/A/10248. The Company has been granted provisional approval under Section 80G(5)(iv) of the Income Tax Act, 1961 with effect from 28 May 2021 and its registration number is AAGCN3396RF20214

b) The Company has a Corporate Social Responsibility (CSR) registration under the provisions of the Companies Act, 2013 with registration number CSR00034191.

2 Material accounting policies

(a) Basis of preparation of financial statements

The financial statements of the Company have been prepared in accordance with generally accepted accounting principles in India (Indian GAAP). The company has prepared these financial statements to comply in all material respects with the accounting standards notified under Section 133 of the Companies Act 2013, read together with the Companies (Accounting Standards) Rules, 2021. The financial statements have been prepared on a going concern basis under the historical cost convention on accrual basis. All assets and liabilities have been classified as current or non-current, wherever applicable as per the operating cycle of the Company as per the guidance as set out in the Schedule III (Division I) to the Act. The financial statements have been prepared and presented in INR. All financial information presented in INR, has been rounded to the nearest thousands unless, except when otherwise stated. The accounting policies adopted in the preparation of financial statements are consistent with those of previous year, unless otherwise stated.

The Company is a Small and Medium sized Company (SMC) as defined in the general instructions in respect of accounting standards notified under Section 211(3C) [Companies (Accounting Standards) Rules, 2006, as amended] and other relevant provisions of the Companies Act, 2013. Accordingly, the Company has complied with the Accounting Standards as applicable to a Small and Medium Sized Company. Pursuant to the exemptions/ relaxations as contained in the notification, Accounting Standard (As) 17- 'Segment Reporting' are not applicable to the Company for the current year. Further, certain recognition and measurement/disclosure requirement 'in terms of Accounting Standard 15 (Revised) - 'Employee Benefits', Accounting Standard 19- 'Leases', Accounting Standard 20 - 'Earning Per Share', 'Accounting Standard 28 - 'Impairment of Assets' and Accounting Standard 29 - 'Provisions, Contingent Liabilities and Contingent Assets' are not applicable to the Company for the current year. Accordingly, the Company has not disclosed certain information in these financial statements pursuant to the above exemptions/relaxations.

(b) Use of Estimates

The preparation of financial statements is in conformity with generally accepted accounting principles in India which require the management to make judgements, estimates and assumptions that affect the reported amount of revenues, expenses, assets and liabilities and disclosure of contingent liabilities at the end of the reporting period. Although these estimates are based upon the management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future periods. Significant estimates used by management in the preparation of these financial statements include the estimates of provision for expenses.

(c) Revenue Recognition

Donations and grants

Donations comprise of receipts from individual and other donors. Donations are recognised as income when there is reasonable certainty that the Company will comply with the conditions attached to them, if any and the donation will be received.

(d) Earnings per share

In the event of dissolution, surplus and assets shall be given to an organization, which has similar objects and no part of the same will go directly or indirectly to anybody specified in section 13(3) of the Income Tax Act, 1961. Accordingly, no disclosures with respect to Earnings/(loss) per share have been given.

(e) Cash and cash equivalents

Cash and cash equivalents includes cash in hand, cash at bank, demand deposits with banks and other short term highly liquid investments with original maturities of three months or less.

(f) Provisions and contingent liabilities

The Company makes a provision when there is a present obligation as a result of a past event where the outflow of economic resources is probable and a reliable estimate of the amount of the obligation can be made.

A disclosure is made for a contingent liability when there is a:

- possible obligation, the existence of which will be confirmed by the occurrence/non-occurrence of one or more uncertain events, not fully within the control of the Company; or
- present obligation, where it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation; or
- present obligation, where a reliable estimate cannot be made.

Where there is a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.

(g) Operating lease

Leases where the lessor effectively retains substantially all the risks and benefits of ownership of the leased term, are classified as operating leases. Payments made under operating leases are charged to the Income and Expenditure Account on the basis of lease agreements on a straight-line basis.

(h) Taxes

Taxes on income are determined on the basis of provisions of the Income Tax Act, 1961 to the extent applicable to the Trust. The Company is registered under section 12A read with Section 12AA(1)(b) of the Income Tax Act, 1961 and are exempt from income taxes. Hence no provision for income tax and deferred tax has been made in the financial statements.

(i) Unrestricted funds

General fund

The Company receives "general funds" which are not subject to grantor stipulations as to use, and the same may be used as per the management's discretion. The surplus earned during the year, being general purpose in nature is carried forward for use in future periods. In case of deficit, if in any year, the same is adjusted against General fund.
